Dharrwany ñunhi CDP-ñur yolhũn ga runu'puynha mala.

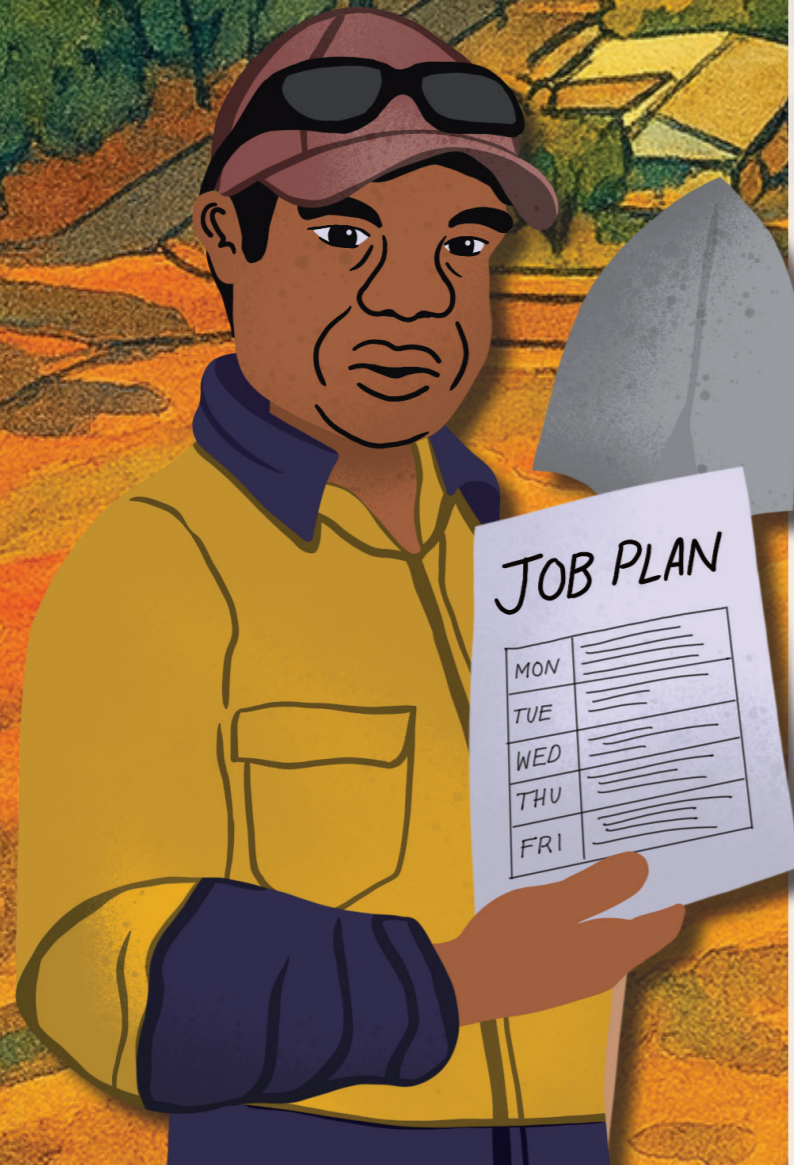
