Dharrwany ṅunhi CDP-ṅur yolṅun ga runu'puynha mala.

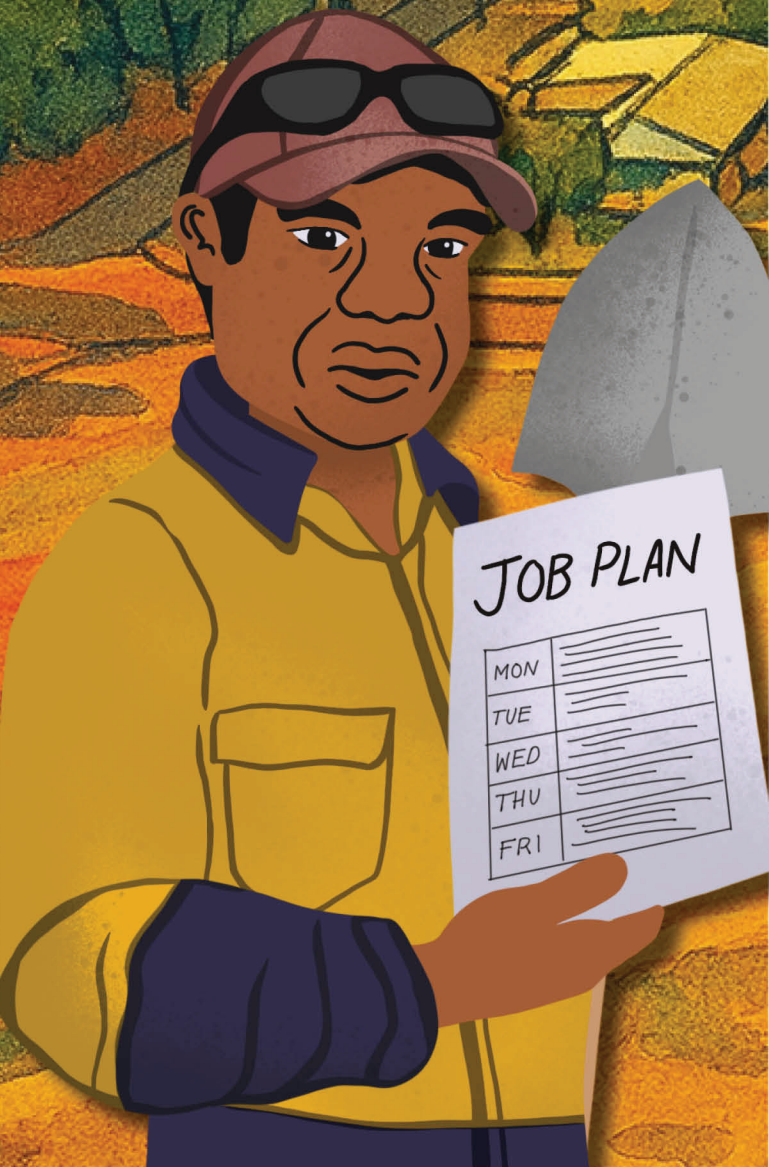
