**THE COURT ORDERS THAT:**

***Class Deadline***

1. Pursuant to ss 33J(1), 33ZF and 33ZG of the *Supreme Court Act 1986* (Vic) (**SC Act**), 4.00 pm AEST on 23 August 2024 (**Class Deadline**) be fixed as the date by which an ‘Acquiring Group Member’ and/or a ‘Holding Group Member’ (as those terms are defined in para [1] of the Second Further Amended Statement of Claim dated 21 July 2022) (collectively, **Group Members**) may:
  - (a) opt out of this proceeding in accordance with order 4 below; or
  - (b) register to participate in this proceeding in accordance with order 12 below



### ***Notice and Opt Out***

2. Pursuant to ss 33X(1)(a) and (5) and 33Y(1) of the SC Act, the form and content of the notices set out in Annexure A (**Abridged Notice**) and Annexure B (**Full Notice**) to these orders (together, **Notices**) are approved.
3. Pursuant to s 33Y of the SC Act, the Notices be given to Group Members in accordance with the following procedure:
  - (a) by 14 June 2024, the defendant shall instruct its share registry service provider, Computershare Investor Services Pty Ltd (**Computershare**), to compile a list of contact details (including the last known postal address and/or email address) for all persons recorded on the defendant's register of members maintained pursuant to ss 168 and 169 of the *Corporations Act 2001* (Cth) (**Crown Share Register**) as:
    - (i) having held shares in the defendant (**Crown Shares**) as at the close of trading on 18 October 2020; and
    - (ii) to the extent not captured by order 3(a)(i) above, having acquired Crown Shares at any time between 11 December 2014 and 18 October 2020 (inclusive) (**Relevant Period**),(in both cases, including any acquisitions of Crown Shares which occurred on or before 18 October 2020 even if settlement of those acquisitions occurred after that date);
  - (b) during business hours between **Wednesday 3 July 2024 (Notification Date)** and **Friday 5 July 2024**, the defendant shall cause Computershare to send a copy of the Abridged Notice:
    - (i) by email to all of the persons referred to in order 3(a) above for whom an email address is recorded; and
    - (ii) by ordinary post to all of the persons referred to in order 3(a) above for whom an email address is not recorded;
  - (c) if any email sent to a person referred to in order 3(b)(i) above experiences a delivery failure, the defendant shall cause Computershare, if a postal address has been provided for that person, to send a copy of the Abridged Notice by ordinary



post to that person within ten (10) business days of receiving notice of that delivery failure;

- (d) during business hours between **Wednesday 3 July 2024 (Notification Date)** and **Friday 5 July 2024**, the plaintiff shall cause a copy of the Abridged Notice to be sent by email to each Group Member who, as at the date of these orders, has registered with the plaintiff's solicitors to participate as a group member in this proceeding;
  - (e) during business hours between **Wednesday 3 July 2024 (Notification Date)** and **Friday 5 July 2024**, the plaintiff shall cause a copy of the Full Notice, together with a copy of the following documents, to be displayed on the website of the plaintiff's solicitors, and to remain continuously so displayed up to and including the Class Deadline:
    - (i) Second Further Amended Statement of Claim dated 21 July 2022;
    - (ii) Defence to Second Further Amended Statement of Claim dated 10 October 2022;
    - (iii) Reply to the Defence to Second Further Amended Statement of Claim dated 7 November 2022;
    - (iv) Rejoinder to Reply to Defence to Second Further Amended Statement of Claim dated 21 December 2022;
    - (v) the orders made by the Honourable Justice Stynes on 22 December 2022; and
    - (vi) these orders; and
  - (f) by the Notification Date, the Commercial Court Registry shall cause a copy of the Full Notice to be posted on the Supreme Court of Victoria website and made available for inspection at the Commercial Court Registry.
4. Pursuant to s 33J of the SC Act, any Group Member who wishes to opt out of this proceeding must, before the Class Deadline:
- (a) deliver to the Commercial Court Registry a completed Notice of Opting Out by Group Member in the form of Attachment B to the Full Notice (**Notice of Opting Out**); or



- (b) submit the required information in the 'Online Opt Out Notice' through the Supreme Court of Victoria website at: <https://www.supremecourt.vic.gov.au/areas/group-proceedings/crown-resorts-shareholder/opting-out> (**Online Opt Out**).
5. Each Group Member who wishes to opt out of this proceeding in accordance with order 4 above must complete the Notice of Opting Out or the Online Opt Out either:
- (a) by personally signing or personally affixing their electronic signature;
  - (b) in the case of a corporation who is a Group Member, by a director of the corporation personally signing or personally affixing their electronic signature;
  - (c) by the Group Member's solicitor personally authorised to act on behalf of the Group Member personally signing or personally affixing their electronic signature as that Group Member's solicitor;
  - (d) in the case of an executor of an estate which is a Group Member, by the executor personally signing or personally affixing their electronic signature; or
  - (e) in the case of a person holding a power of attorney for a Group Member, by the attorney personally signing or personally affixing their electronic signature.
6. Unless a Notice of Opting Out or Online Opt Out is completed by or on behalf of a Group Member by that Group Member personally in accordance with order 5(a) above, or by a person in accordance with orders 5(b) to (e) above, any Notice of Opting Out or Online Opt Out otherwise received by the Court will not be treated as a valid and effective opt out notice for the purposes of s 33J of the SC Act.
7. The Notices may be amended by the plaintiff's solicitors before they are published or distributed in order to correct any typographical error, or any postal, website or email address or telephone number or other non-substantive error.
8. If the Notice is amended by Maurice Blackburn in accordance with paragraph 7 of this Order, Maurice Blackburn shall provide a copy of the amended Notice to the Commercial Court Registry of the Supreme Court of Victoria by **4:00pm on 26 June 2024**.



9. If, on or before the Class Deadline, the solicitors for any party receive a notice purporting to be an opt out notice referable to this proceeding, the solicitors are to email such notice to the Commercial Court Registry within three (3) business days after the Class Deadline with a notation specifying the date it was received by the solicitors, and the notice shall be treated as a Notice of Opting Out received by the Court at the time when it was received by the solicitors.
10. The parties' solicitors have leave to inspect the Court file and to:
- (a) copy any Notices of Opting Out filed by or on behalf of Group Members; and
  - (b) obtain information relating to any Online Opt Outs submitted by or on behalf of Group Members.
11. The costs of and incidental to sending the Notices (including any disbursements incurred) shall be paid by the plaintiff and defendant in equal shares, but on the basis that those costs will subsequently fall to be costs in the proceeding. For the avoidance of doubt, addressing enquiries by Group Members and members of the public in relation to the Notices is work that is incidental to the Notices.

***Claim Registration and Class Closure***

12. Any Group Member may, by the Class Deadline, register their claim by:
- (a) completing the online registration process via the website of the plaintiff's solicitors at the web address specified in the Notices; or
  - (b) delivering to the plaintiff's solicitors a completed Registration Form in the form of Attachment A to the Full Notice,
- (such Group Members being **Registered Group Members**) and as part of that process shall provide, or take reasonable steps to provide, the following information:
- (c) the Group Member's name (or names in the case of joint security holders) and address and/or email address;
  - (d) any relevant Holder Identification Number (**HIN**) or Security Reference Number (**SRN**) or equivalent reference number (if available) and in respect of Crown Shares;



- (e) the number of Crown Shares held by the Group Member as at the commencement of trading on 11 December 2014;
  - (f) the number of Crown shares held by the Group Member as at the close of trading on 23 October 2020;
  - (g) for each acquisition of Crown Shares between 11 December 2014 and 23 October 2020 (inclusive), the date of acquisition, the quantity of Crown Shares acquired and the price of Crown Shares acquired (if available); and
  - (h) for each sale or disposal of Crown Shares between 11 December 2014 and 23 October 2020 (inclusive), the date of sale or disposal, the quantity of Crown Shares sold or disposed of and the price of Crown Shares sold (if available).
13. For the avoidance of doubt, Group Members who have registered their claim with the plaintiff's solicitors before the date of this Order and have provided, or taken reasonable steps to provide, the information set out in order 12(c) to (h) above, are taken to be Registered Group Members.
14. Failure by a Group Member to provide all the information set out in order 12 above during the registration process will not render the Group Member's registration invalid provided the Group Member is identifiable as such based on the information provided.
15. Pursuant to ss 33X, 33Y, 33ZF and 33ZG of the SC Act, any Group Member who, prior to the Class Deadline, does not:
- (a) opt out of this proceeding in accordance with order 4 above; or
  - (b) register their claim in accordance with order 12 above,
- shall, subject to further order, remain as a Group Member for all purposes, but shall not be entitled to any payment or other benefit from any settlement of the proceeding that is entered into between the parties before the commencement of the trial of the proceeding fixed pursuant to order 44 of the case management orders, and is subsequently approved by the Court pursuant to s 33V of the SC Act.



***Registration Data***

16. By 4.00 pm on 19 September 2024, the plaintiff must deliver to the defendant (in electronic form), to the extent it has been captured, the following information in respect of each Registered Group Member:

- (a) a unique identification number for each Registered Group Member;
- (b) the information referred to in order 12(e) to (h) above; and
- (c) any amendments to the information as notified to Maurice Blackburn by that date.

*Greg Lieberman v Crown Resorts Ltd (Proceeding No. S ECI 2020 04566)*

### CROWN RESORTS CLASS ACTION

Note: This notice relates to the Crown Resorts Class Action, which is being conducted in the Supreme Court of Victoria. The Crown Resorts Class Action is separate from an earlier class action against Crown Resorts Ltd that was brought on behalf of shareholders in the Federal Court of Australia (being the Crown (China Arrests) Class Action). You will need to register or opt out separately for this class action in the manner set out below.

### WHAT IS THIS?

The Supreme Court of Victoria has ordered that this abridged notice be distributed for the information of group members in the Crown Resorts Class Action.

Any person who acquired shares in Crown Resorts Ltd (ASX: CWN) (**Crown**) between 11 December 2014 and 18 October 2020 (inclusive) (**Relevant Period**), or who owned shares in Crown as at the close of trading on 18 October 2020, should read this notice carefully.

**IMPORTANT:** There is a more detailed Opt Out and Registration Notice which contains further information in relation to the matters set out below, and which you should read. You can access that Notice on Maurice Blackburn's website at <https://www.mauriceblackburn.com.au/class-actions/join-a-class-action/crown-money-laundering-risk-class-action/> or on the Supreme Court of Victoria's website at <https://www.supremecourt.vic.gov.au/areas/group-proceedings/crown-resorts-shareholder>.

### WHAT IS THE CLASS ACTION?

The class action relates to conduct engaged in by Crown, and Crown's disclosures to investors and potential investors, during the Relevant Period. The plaintiff commenced the class action on 11 December 2020, on his own behalf and on behalf of **Group Members**.

In summary, the plaintiff claims that, during the Relevant Period, Crown made various statements that were misleading or deceptive (or likely to mislead or deceive) and failed to disclose information of which it was aware (or ought to have been aware), to investors and potential investors. The alleged statements and information relate, in particular, to: (i) the appropriateness of Crown's systems for ensuring (and monitoring) compliance with, and its general approach to, relevant Australian regulatory requirements applicable to casino operations (including regulatory requirements relating to anti-money laundering and counter-terrorism financing and the payment of casino tax); (ii) Crown's relationship with the regulatory authorities responsible for enforcing those regulatory requirements; and (iii) the appropriateness of Crown's systems for ensuring (and monitoring) compliance by its directors and officers with statutory duties relating to corporate governance. The plaintiff also claims that, during the Relevant Period, Crown conducted its affairs in a way that was contrary to the interests of its members as a whole.

The plaintiff seeks relief for Group Members, including damages to compensate Group Members for the loss which he alleges they suffered as a result of their investment in Crown shares.

Crown denies the allegations made against it, and is defending the class action.

## **AM I PART OF THE CLASS ACTION?**

You are receiving this notice because, based on the information recorded on Crown's share register, **you have been identified as a potential Group Member in the class action.**

You are a Group Member in the Crown Resorts Class Action if:

- you acquired one or more Crown shares during the Relevant Period (i.e. 11 December 2014 to 18 October 2020 (inclusive)); and/or
- you owned one or more Crown shares as at the commencement of trading on 11 December 2014, and still held at least one of those shares as at the close of trading on 18 October 2020.

## **WHAT ARE MY OPTIONS?**

### **1. REGISTER TO PARTICIPATE:**

If you are a Group Member, and you wish to participate in the class action and potentially receive some compensation from any future settlement in the class action that is entered into on or before the commencement of the trial of the class action (which is currently scheduled to commence on a date not before 7 April 2026) and which is subsequently approved by the Court, **you must register your claim with Maurice Blackburn by no later than 4.00 pm (AEST) on 23 August 2024.** There is no cost to register your claim (any legal costs incurred by Maurice Blackburn will only be payable out of any compensation that may ultimately be recovered for the benefit of Group Members). You can register your claim via Maurice Blackburn's website at <https://www.mauriceblackburn.com.au/class-actions/join-a-class-action/crown-money-laundering-risk-class-action/> or by delivering to Maurice Blackburn a completed Registration Form (see Attachment A to the more detailed Opt Out and Registration Notice referred to above). (Note, if you have already registered with Maurice Blackburn to participate in this class action (as opposed to the Crown (China Arrests) Class Action referred to above), you do not need to register again.)

### **2. OPT OUT:**

If you are a Group Member, but **do not want to participate in or have your rights determined in the class action, you must opt out by 4.00 pm (AEST) on 23 August 2024.** If you choose to opt out, you will cease to be a Group Member, and will not be entitled to receive a distribution payment from (and will not be bound by) any future settlement or judgment in the class action. Information about how to opt out is contained in the more detailed Opt Out and Registration Notice available on Maurice Blackburn's website at <https://www.mauriceblackburn.com.au/class-actions/join-a-class-action/crown-money-laundering-risk-class-action/> or on the Supreme Court of Victoria's website at <https://www.supremecourt.vic.gov.au/areas/group-proceedings/crown-resorts-shareholder>.

### **3. DO NOTHING:**

If you are a Group Member and you neither opt out nor register **by 4.00 pm (AEST) on 23 August 2024**, then you will remain a Group Member in the class action but **you will not (unless the Court orders otherwise) be entitled to receive any payment or benefit if there is a settlement on or before the commencement of the trial of the**

**class action** (which is currently scheduled to commence on a date not before 7 April 2026) and which is subsequently approved by the Court.

**IT IS IMPORTANT THAT YOU READ THIS NOTICE CAREFULLY  
BECAUSE IT MAY AFFECT YOUR LEGAL RIGHTS**

If you are a Group Member in this class action you have three options:

1. **Register to participate** in the class action by no later than **4.00 pm (AEST) on 23 August 2024** (see 'Option 1' on pages 5-6).
2. **Opt out** of the class action by no later than **4.00 pm (AEST) on 23 August 2024** (see 'Option 2' on pages 6-7).
3. **Do nothing** by **4.00 pm (AEST) on 23 August 2024** (see 'Option 3' on page 7).

The steps that you need to take, and the consequences of each option, are explained in this notice.

## WHY ARE YOU RECEIVING THIS NOTICE?

1. The purpose of this notice is to inform you of a class action in the Supreme Court of Victoria (Crown Resorts Class Action) which has been brought against Crown Resorts Ltd (**Crown**). The plaintiff in the class action is Greg Lieberman. The lawyers for the plaintiff are Maurice Blackburn Lawyers (**Maurice Blackburn**).
2. The class action relates to conduct engaged in by Crown and Crown's disclosures to investors, and potential investors, during the period 11 December 2014 to 18 October 2020 (inclusive) (**Relevant Period**).
3. The plaintiff commenced the class action on 11 December 2020, on his own behalf and on behalf of **Group Members**.
4. The Court has ordered that this notice be published for the information of those persons who might be Group Members in the class action. **You are receiving this notice because you have, based on the information recorded on Crown's share register, been identified as a potential Group Member in the class action.**
5. This notice provides important information about:
  - a. the class action;
  - b. what you need to do if you wish to register to participate in the class action, and potentially receive some compensation if the parties agree to a settlement of the class action on or before **the commencement of the trial of the class action (which is currently scheduled to commence on a date not before 7 April 2026)** and which is subsequently approved by the Court;
  - c. what you need to do if you wish to remove yourself from participating in the class action (i.e. 'opt out'); and
  - d. how your rights might be affected if you register to participate, or opt out, or do nothing, before the deadline, being **4.00pm (AEST) on 23 August 2024**.
6. You should read this notice carefully. Any questions you have concerning the matters contained in this notice should **not** be directed to the Court. If there is anything in it that you do not understand, you should seek independent legal advice or contact Maurice Blackburn (see contact details below).

## **WHAT IS A CLASS ACTION?**

7. A class action is a type of legal proceeding in which the claims of a group of persons (the group members), all of whom have similar or related claims, are brought in a single proceeding. A class action is brought by the plaintiff on behalf of the group members, and the plaintiff is not required to seek the consent of group members before commencing a class action on their behalf.
8. Nevertheless, a group member may (as explained below) opt out of a class action which is commenced on their behalf. Unless a group member opts out, they are automatically covered by the class action and bound by the outcome, even if they did not take any active steps to join it before it was commenced.

## **WHAT IS THIS CLASS ACTION?**

9. The Crown Resorts Class Action has been brought against Crown and, as noted above, relates to conduct engaged in by Crown, and Crown's disclosures to investors and potential investors, during the Relevant Period (i.e. 11 December 2014 to 18 October 2020 (inclusive)).
10. In summary, the plaintiff claims that, during the Relevant Period:
  - a. Crown made various statements to investors, and potential investors, in Crown shares that were misleading or deceptive, or likely to mislead or deceive. Those statements included statements relating to:
    - i. the appropriateness of Crown's systems for ensuring (and monitoring) compliance with relevant Australian regulatory requirements applicable to casino operations (including regulatory requirements relating to anti-money laundering and counter-terrorism financing and the calculation and payment of casino tax), and its general approach to such regulatory requirements;
    - ii. Crown's relationship with the regulatory authorities responsible for enforcing those regulatory requirements; and
    - iii. the appropriateness of Crown's systems for ensuring (and monitoring) compliance by its directors and officers with statutory duties relating to corporate governance.
  - b. Crown failed to disclose to investors, and potential investors, in Crown shares information relating to the above matters of which it was aware, or ought to have been aware, and which was likely to influence those persons in deciding whether to acquire or dispose of Crown shares.

- c. Crown conducted its affairs in a way that was contrary to the interests of its members as a whole.
  - d. By reason of the above matters, investors in Crown shares have suffered loss and damage.
11. The plaintiff seeks relief for Group Members, including damages to compensate Group Members for the loss which he alleges they suffered as a result of their investment in Crown shares.
12. Crown denies the allegations made against it and is defending the class action.
13. The detailed allegations are set out in the plaintiff's Second Further Amended Statement of Claim. A copy of that document, as well as Crown's Defence to the allegations and other relevant documents, are available to be viewed on the websites referred to below.

**Note: The Crown Resorts Class Action, which is being conducted in the Supreme Court of Victoria, is separate from, and relates to matters that are different to those that were alleged in, an earlier class action against Crown that was brought by Maurice Blackburn on behalf of shareholders in the Federal Court of Australia (being the Crown (China Arrests) Class Action). The Crown (China Arrests) Class Action has now concluded. Thus, if you registered to participate in, or opted out of, the Crown (China Arrests) Class Action, that registration or opt out is NOT effective for the purposes of this class action – this means that you will need to register or opt out separately for this class action in the manner set out below.**

## **ARE YOU A GROUP MEMBER?**

14. You are a Group Member in the class action if, subject to some limited exceptions, either or both of the following sub-paragraphs (a) and (b) applies to you:
- a. you acquired one or more Crown shares during the Relevant Period (i.e. 11 December 2014 to 18 October 2020 (inclusive)); and/or
  - b. you owned one or more Crown shares as at the commencement of trading on 11 December 2014, and still held at least one of those shares as at the close of trading on 18 October 2020.
15. You have received this notice because, based on the information recorded on Crown's share register, you have been identified as someone who may be a Group Member in the class action.



16. If neither of the above sub-paragraphs 14.a or 14.b applies to you, you may disregard this notice. **If either or both of the above sub-paragraphs 14.a or 14.b applies to you, you should read this notice carefully as it will affect your rights.**
17. If you are unsure whether or not you are a Group Member, you should:
- a. contact Maurice Blackburn (see contact details below); or
  - b. seek your own independent legal advice without delay.

## **WHAT ARE YOUR OPTIONS?**

18. If you are a Group Member in this class action, you have three options, which are explained in detail below.

### **Option 1 – Register to Participate**

If you are a Group Member and you wish to participate in the class action and potentially receive compensation if the parties agree to a settlement of the class action on or before **the commencement of the trial of the class action (which is currently scheduled to commence on a date not before 7 April 2026)**, and which is subsequently approved by the Court, you should register your claim with Maurice Blackburn promptly. **There is no cost to register your claim.**

You may register your claim by:

- completing the online registration process via the website of Maurice Blackburn (<https://www.mauriceblackburn.com.au/class-actions/join-a-class-action/crown-money-laundering-risk-class-action/>); or
- by delivering to Maurice Blackburn a completed Registration Form (see **Attachment A** to this notice).

When registering your claim, you will not be required to enter into any contract or agreement with Maurice Blackburn, but you will need to provide your contact details, together with details of your holdings of Crown shares during the period 11 December 2014 to 23 October 2020 (inclusive).

By registering your claim, you will remain as a Group Member in the class action and your claims will be collectively resolved through the class action. This means that you will be bound by any settlement that is approved by the Court or judgment in the class action. If the class action is successful, you may be entitled to share the benefit of any order, judgment or settlement in favour of the plaintiff and Group Members in the class action (although you may have to satisfy certain

conditions before your entitlement arises). If the class action is unsuccessful, or is not as successful as you might have wished, you will not be able to pursue the same claims and may not be able to pursue similar or related claims against Crown in other legal proceedings.

**IMPORTANT:**

**(1) If you wish to register to participate in the class action you should do so by no later than 4.00 pm (AEST) on 23 August 2024, otherwise you may miss out on any entitlement to share in the benefit of a settlement in favour of the plaintiff and Group Members.**

**(2) If you have already registered with Maurice Blackburn to participate in this class action (as opposed to the Crown (China Arrests) Class Action referred to on page 4 above), you do not need to register again.**

**Option 2 – Opt Out**

If you are a Group Member as defined above, but do **not** want to participate in or have your rights determined in the class action, **you must opt out by 4.00 pm (AEST) on 23 August 2024.**

If you choose to opt out:

- you will cease to be a Group Member in the class action;
- you will not be entitled to share the benefit of any order, judgment or settlement in favour of the plaintiff and Group Members in the class action;
- you may be at liberty to bring your own separate claim against Crown, provided that you file Court proceedings within the time limit applicable to your claim. If you wish to bring your own claim against Crown, you should seek your own independent legal advice about your claim and any applicable time limits prior to opting out.

**How to opt out**

If you wish to opt out of the class action, you must:

- submit the required information in the online opt out notice at the Supreme Court of Victoria website at <https://www.supremecourt.vic.gov.au/areas/group-proceedings/crown-resorts-shareholder/opting-out>; or
- complete a '**Notice of Opting Out by Group Member**' in the form of Attachment B to this notice, and return it promptly to the Commercial

Court Registry of the Supreme Court of Victoria at the address shown on the form.

Each Group Member seeking to opt out should fill out a separate online submission or Notice of Opting Out by Group Member form.

**IMPORTANT: The notice must be submitted online or reach the Registry by no later than 4.00 pm (AEST) on 23 August 2024, otherwise it will not be effective.**

### **Option 3 – Do Nothing**

If you are a Group Member and you decide **not to opt out and do not register:**

- You will **not** be entitled to receive any payment or other benefit if there is a settlement on or before **the commencement of the trial of the class action (which is currently scheduled to commence on a date not before 7 April 2026)** and which is subsequently approved by the Court, unless the Court makes an order permitting you to participate.
- You **may lose** your right to make a claim against Crown in relation to the same (or similar) claims alleged in the Crown Resorts Class Action if there is a settlement.
- You may be given another opportunity to register in the future, but not in relation to a settlement reached on or before **the commencement of the trial of the class action (which is currently scheduled to commence on a date not before 7 April 2026)** and which is subsequently approved by the Court. If, following a trial, the judgment concludes that Group Members may be entitled to receive compensation, then you may be eligible to receive compensation.
- If there is no settlement, you will be bound by any final judgment determined at trial.

Thus, if you wish to remain a Group Member in the class action, you are encouraged to register your claim (Option 1 above) before the deadline of **4.00 pm (AEST) on 23 August 2024**. As noted above, there is no cost to register your claim.

## **INFORMATION ABOUT LEGAL COSTS AND HOW THE CLASS ACTION IS BEING FUNDED**

19. **Group Members are not, and will not be, liable for any legal costs out of their own pocket** by registering to participate, or otherwise remaining as a Group Member, in the class action.
20. If the class action is unsuccessful, **Group Members will not be liable to pay any legal costs** (and Maurice Blackburn will not be entitled to recover any legal costs).
21. If the class action is successful (that is, if any monetary compensation is recovered by way of settlement or judgment for the plaintiff and Group Members), the legal costs that are payable to Maurice Blackburn will only be deducted from, and will not exceed, the amount of monetary compensation recovered. The basis on which those legal costs will be calculated is governed by a 'group costs order' (**GCO**) which was made by the Supreme Court of Victoria on 22 December 2022.
22. Pursuant to the GCO, if any monetary compensation is recovered by way of settlement or judgment for the plaintiff and Group Members in the class action, the legal costs payable to Maurice Blackburn will be calculated as a percentage of the amount recovered, as follows:

<b>For each dollar of monetary compensation that is recovered between:</b>	<b>The applicable GCO percentage (being the legal costs payable to Maurice Blackburn, incl GST) is:</b>
\$0 - \$100 million	27.5%
\$100.1 million - \$150 million	22.0%
Over \$150 million	16.5%

23. This means that the legal costs payable to Maurice Blackburn for conducting the class action will not exceed 27.5% of any amount that is ultimately recovered.
24. The Court may vary the GCO (including the percentages set out in the above table) at any time during the class action, but if that occurs the Court will take into account the interests of Group Members in any re-assessment, and Group Members will be notified of any change.
25. Liability for payment of the legal costs payable to Maurice Blackburn will be shared between the plaintiff and all Group Members, by way of deduction from their respective entitlements (regardless of whether or not those Group Members have entered into agreements with Maurice Blackburn).
26. The GCO also has the effect that, if the class action is unsuccessful, Maurice Blackburn will be required to pay any costs payable to Crown – neither the plaintiff

nor the Group Members will be required to pay those costs. Maurice Blackburn must also give any security for the costs of Crown that the Court may order the plaintiff to give.
