Maurice Blackburn Lawya-ny mala dhuwal ŋunhi walal ŋuli ga djäma Balandawal romŋur. Dhiyaŋ bala walal ga ŋurru-ŋupa'ŋupan gunyambi lawya-ny mala märramaw' yolŋuw ga Northern Territory Government-ku. Dhiyalaja court case-ŋur maŋda ŋakaram Dylan Jenkins-thu ga Aaron Hyde-dhu. Ga bitjan maŋda waŋany ŋunhi NT Government-thu bakmaram rom ga yatjuyam djäka djamarakuŋw' Youth Detention (wäŋa). Nyuntuju nyampula jinta NT Youth Justice Class Action legal case-kirli, kujalpanpa nyinaja youth detention-rla 1 August 2006 manu 27 November 2017. Dylan Jenkins manu Aaron Hyde wangkaja-pala NT Government-rii-jana ngawungku nyayirniri mardarnu-jalangu warnu-patu youth detention-irla.

NT Government wangkajarl kulalu rdilyki-pungu law. Wangkajarl kapulu nyarra compensation yinyi, yangka kujalpanpa nyinaja youth detention nyampu-puru 1 August 2006 manu 27 November 2017.
