

## Registration Form

### False imprisonment of young people class action

**You may be eligible for compensation if:**

1. you faced charges in the Children's Court of New South Wales; and
2. you were arrested prior to 20 May 2014 by the New South Wales police for a breach of bail conditions; and
3. you were not actually on bail at the time you were arrested, or you were on bail but not subject to the condition you were arrested for.

If this happened to you, you must fill out this form and return it to Maurice Blackburn **by 9 October 2015** if you want to get compensation.

If the form is not sent on time **you will not get any compensation.**

You must answer questions 1-4. You must also answer question 5, question 6, or question 7 (or more than one of these questions).

Questions 8-20 are optional, however if you do not answer them it may significantly reduce the amount of compensation you are able to recover, including reducing compensation to \$0.

If you were wrongly arrested more than once, you should fill out **a new Registration Form for each arrest.**

17.	Were you humiliated in any way? For example were you arrested in a public place?	
18.	Are you an Aboriginal or Torres Strait Islander person?	
19.	Do you suffer from any mental illness or physical disability?	
20.	Is any other information relevant to your claim against the police?
